2. The maximum age limit of students for D.A.E (Morning / Double Shift Program) should be 22 Years and for D.A.E Self Help Evening Program should be 35 Years on 10-01-2020.

No Registration forms will be accepted without original Migration Certificate (In case of students who have passed S.S.C./H.S.C Examination from other Boards) and attested copies of other required documents viz marks sheet and Provisional Certificate of the last examination passed by the applicant.
4. Eligibility for Registration is S.S.C (Science Group) / T.S.C / Matric Technical with at-least 33% Marks as determined by Inter Board Committee of Chairmen (IBCC) Islamabad in its 156th Meeting held on 06th & 07th July, 2017.
